



TAA Wins Task Force Contract for Natural Resources Support Services, Afghanistan

The Task Force for Business and Stability Operations (TFBSO) has awarded Transformation Advisors Group, LLC (TAA) a contract to provide general management services, including field site management; engineering, drilling, and technical services; and Village Stability Operations (VSO) management support.
